The issue is that a larger ferry would allow for greater distance between passengers where a small one does not.</p> <p>This raises a final issue of how social distancing is intended to be maintained on an overnight bus, which is presumably not frequent and may therefore have many passengers.</p> <p>On a related note, an issue remains that the profitability of HKR transport is still undisclosed, despite the fact that it is clear the ferries in service have been in service for a quarter century or longer and would have paid for themselves multiple times over. Yet the lack of profit remains HKR's excuse to continue to try to skimp on transport services.</p>

As such, we want to stay in DB, however the 24-hour ferry service is crucial to our decision to do so.</p> <p>To find out that HKRI is once again trying to cancel the overnight ferry and use a backdoor route to replace it with buses, without conducting a proper public consultation, is shocking and extremely concerning.</p> <p>DB residents have not been consulted by HKRI as to whether we wish to keep the overnight ferry service. The Passenger Liaison Group/City Owners Committee do not represent the wishes of the general residents of DB - we are never consulted prior to decisions being made, and we have no way to make our voices heard.</p> <p>While I understand that the pandemic has necessitated temporary measures, these should only be temporary - once life gets back to 'normal', the ferry service should too.</p> <p>The decisions made by HKRI recently as to which ferries are used at which time of day have been perplexing to say the least. At the busiest times, small ferries have been used, with passengers crammed together - far from ideal during a pandemic - and at night times, when ridership is low, large ferries have been used. HKRI could make cost savings simply by making more sensible choices on which vessel should service which sailings.</p> <p>The proposed bus service will take significantly longer to reach DB than the ferry service. It also does not service a large proportion of villages in the community, Midvale Village included.</p> <p>I am greatly concerned about the prospect of having to take a bus - which is statistically far more dangerous than a ferry - when drivers are tired at night. In addition, as a woman, I do not want to have to walk the last part of the journey alone at night. Key advantages: only one - probably small vehicle - required for such night internal transfer thus less pollution and also less cost for the DB transportation dept.
